

C I R C U L A R

(I). Change of Name of Association.

1. Whereas the promoters of Industrial units located in Industrial Area, Gangyal formed an Association called "Association of Industries" in 1983.
2. Whereas the said Association was got duly registered as a society with the Registrar of Societies, J&K under J&K Societies Registration Act, under Registration No. 813-S dated 12.12.1983.
3. Whereas, after sometime, members in the Annual General Body meeting held on 11.06.1990 decided to rename the Association by adopting the new name as "*Association of Small Scale Industries*".
4. Whereas, after framing and adopting the new name of "*Association of Small Scale Industries*", the relevant documents concerning the framing and adoption of new name were filed / presented before the notified authority viz. Registrar of Societies, J&K for effecting change in the name of the Association.
5. Whereas the office of Registrar of Societies, J&K, informed the Association vide its office No. 813-RC/657 dated 23.03.2009 & No. 813-RC/742 dated 26.11.1992 that the name of this Association cannot be changed on the ground that provisions governing grant of Registration under J&K Societies Registration Act do not permit any change in the name of the society once it is registered.
6. Whereas the present team of office bearers of ASSI also approached the Registrar of Societies, J&K to effect the necessary change in their records, the request was once again turned down on the same plea as at para (5) above.
7. Whereas a very piquant situation arose due to this uncalled for and unnecessary change in the name of the Association in 1990, the matter was put up before the AGM held on 07.11.2009

8. Whereas the AGM, after deliberating upon the issue, decided to seek opinion / views of the members of the Association and authorized the Executive Committee of ASSI to act accordingly.
9. Whereas the decision of AGM was circulated amongst the members seeking their comments but no member cared to express his opinion in writing.
10. Whereas the matter was accordingly placed before the Executive Committee Meeting held on 11.12.2009 and the said Committee was requested to decide the matter as per decision of AGM.
11. Whereas the Executive Committee, deliberated upon this issue in length and considered all the relevant facts of the case.
12. Whereas the Executive Committee after having considered all facts unanimously gave its approval to revert back to the already registered name i.e. "*Association of Industries*" instead of "*Association of Small Scale Industries*". and authorized the President & General Secretary to take further appropriate action.
13. Now, therefore, in pursuance of the approval of Executive Committee held on 11.12.2009, the name of the "*Association of Small Scale Industries*" shall be, and may deemed to have been, reverted back to "*Association of Industries*" which is already registered as a society with Registrar of Societies, J&K under J&K Registration of Societies Act.
